Welcome to ebm-papst Slovenija,

in order to make your visit as pleasant as possible, please observe and adhere to safety rules listed in this flyer, as these are for your own protection.

You are obliged to treat all information which is not common knowledge as strictly confidential.



Checking in and out

Please only park in the parking lots and spaces indicated. Please wear the visitor ID issued to you so that it is clearly visible and return it to headquarters at the end of your visit. The check-in and check-out process will be conducted by your quide at ebm-papst.



Photography/cellphones (smartphones)

It is not permitted to take photographs or record videos/footage on the factory site (although permission may be granted after consulting your contact)



Guided tours

Do not break off your group. Remain close to the ebm-papst employee in question and observe all safety instructions that they give you.



Traffic routes

Beware of traffic. Our pedestrian routes are not separated from transport routes.



ESD protection

In order to protect electronic components and assemblies against electrostatic discharge, these are not permitted to be touched. The specified safety measures must be adhered to in indicated areas.



Environmental protection

Use the collection containers provided to dispose of waste. Please separate waste into the categories specified and dispose of it accordingly.



Protection of employees and the environment

Your ebm-papst coordinator will inform you about the points which are relevant for your remit. It is mandatory to observe legal regulations concerning the protection of employees and the environment. Hazardous substances used by you on the site must be approved by ebm-papst before application. Hazardous substances must be stored in suitable containers and labeled appropriately. Authorization is required for work involving high temperatures, such as welding, soldering or cutting and grinding tasks. In this case, use the document "Permit for work that poses a fire hazard".



Equipment brought onto the site

Any equipment brought onto the site must satisfy legal regulations concerning safety and environmental protection. In particular, the work tools must be tested in accordance with accident-prevention regulations and marked with the corresponding test symbols.



Personal protective equipment

On construction and assembly sites, personal protective equipment which satisfies accident-prevention regulations must be worn.







Prohibited access /equipment

In protected areas, a general access ban is in effect for unauthorized persons. Machines, tools and materials are not permitted to be touched.





Observe the notices on machines and plants which can pose a danger to persons fitted with implants such as pacemakers or other medical-technical devices due to strong electric or magnetic fields.



First aid

Please immediately report every injury and every accident to your contact on the premises of ebm-papst. Your contact will then arrange for assistance and inform the company medics.



Smoking/alcohol ban

With the exception of the labeled areas, smoking is prohibited across the entire factory site, including the parking lots. The consumption of alcohol and other intoxicants on the factory site is prohibited.



Conduct in case of fire

Escape and evacuation routes are indicated by appropriate symbol. Maps of escape routes can be found hanging up in every entrance area. Escape routes and emergency exit doors must always be kept clear. When the alarm sounds, please leave the building quietly and immediately. Elevators are not permitted to be used. Make your way to the indicated assembly points and, once there, await further instructions from the persons responsible.


