The substances respectively groups no. 1 – 10, are or will be restricted in electrical and electronic equipment (EEE) in the EU. Exemptions by law are granted (RoHS, Annex III), but have to be declared.

Declaration of phthalates is necessary, although restricted not till 22nd July 2019 (see Directive EU 2015/863).

The limit value refers to the weight of the substance in the homogenous material.
